- 5- Request correction of personal data if it is incomplete or incorrectly processed,
- **6-** Request the deletion or destruction of your personal data within the framework of Article 7 of the Law,
- 7- Object to the emergence of a result against you by analyzing your processed personal data exclusively with automated systems,
- 8- Request the compensation of your damage in case you suffer damage due to unlawful processing of your personal data
